Please repair ball marks on greens, rake bunkers, and use provided sand & seed to replace divots.

Water refill stations and restrooms are accessible after holes 4, 13, and at the clubhouse after hole 9.

A respectful and reasonable flow of play is expected where time on course should not exceed 4 hours, 40 minutes. Please choose appropriate tees that suit your game.

Staff will not warn or remove players from the course due to lightning and inclement weather. Play at your own risk.
